



- BELOW GROUND DRAINAGE
- ALL ITEM AS APPLICABLE TO RELEVANT ON-SITE WORKS
- NEW DRAINS TO BE 110 mm Ø OSMA OR MARLEY U-PVC PIPES LAID TO 1:40 MINIMUM FALL OR AS SPECIFIED BY THE MANUFACTURER
 - ALL DRAINS TO BE BEDDED IN GRANULAR BED OF PEA-SHINGLE 150 mm DEEP WITH 100 mm THICK PEA-SHINGLE COVER PRIOR TO TRENCH BACKFILL
 - CHECK ALL LEVELS ON COMPLETION TO ENSURE REQUIRED FLOWS ARE ACHIEVED
 - ANY NEW DRAINS ARE TO BE FULLY TESTED ON COMPLETION TO ENSURE WATER TIGHTNESS
 - WHERE ANY DRAINS PASS THROUGH WALLS BELOW GROUND LEVEL PROVIDE 75 mm THICK PRE-CAST CONCRETE PLANK LINTELS OVER WITH A RIGID SHEET MATERIAL TO BE POSITIONED AROUND PIPE WORK PERIMETER TO PREVENT ACCESS FROM VERMIN
 - PIPES TO HAVE MINIMUM 50 mm PERIMETER VOID MAINTAINED FOR GROUND MOVEMENT
 - ALL DRAINS TO BE LAID TO A MINIMUM GRADIENT OF 1:40 UNLESS SPECIFIED OTHERWISE ON DRAWINGS OR AS AGREED ON SITE
 - DRAINS MUST NOT BE CONNECTED INTO AN EXISTING MANHOLE AGAINST THE EXISTING DRAIN DIRECTION OF FLOW
 - DRAINAGE LAYOUT MAY BE ADJUSTED TO THAT INDICATED TO SUIT SITE CONDITIONS PROVIDING PRIOR AGREEMENT WITH LA INSPECTORATE

ALL NEW DRAINS ARE TO BE 110 mm Ø U-PVC MARLEY OR OSMA DRAINAGE COMPONENTS AND LAID TO MINIMUM FALLS AS REQUIRED BY THE APPROVED DOCUMENTS AND TO SUPPLIERS STANDARDS ON 150 mm DEEP BED + SURROUND OF PEA-SHINGLE
